The Tender cost will be Rs.605/- should be submitted in the form of Demand Draft which shall be drawn from Nationalised/Scheduled Bank as crossed DD in favour of Managing Director, Supplyco, payable at Ernakulam or cash payment can be done in the Head Office of Supplyco at Kadavanthra, Ernakulam .Tender form can be obtained from the Supplyco Head Office on remitting the above amount on above mode on any working days during office hours from 10.00 AM to 5.00PM

Terms & Conditions

- The work shall be executed as per the specification of drawing, estimate and the direction of the Civil, Electrical Engineering wing of Supplyco.
- The EMD of Rs.6,750/- should be submitted in the form of Demand Draft which shall be drawn from Nationalized / Scheduled Bank in the form of crossed DD in favour of Managing Director, Supplyco, payable at Ernakulam.
- EMD of unsuccessful tenders will be refunded without any interest on finalization of the contract with the successful Tenderer or on the expiry of the validity period whichever is earlier.
- The successful tenderer will deposit a Security Deposit of (5% of contract amount)/- in the form of a crossed DD in favour of Managing Director, Supplyco, payable at Ernakulam.
- The completion time of the project is 90 days from the date of acceptance of the Work order.
- Payment to the contractor shall be released only as per the certification and recommendation of the Civil, Electrical Engineering wing of Supplyco.
- Extra items, if any, shall be carried out only after getting prior approval from Supplyco.
- Defect Liability period shall be 01 year from the date of completion of works, as certified by the Civil, Electrical Engineering wing Supplyco
- SD will be refunded after expiry of the defect liability period and work certification by the Civil, Electrical Engineering wing of Supplyco as per the PWD norms.
- All statutory deductions shall be made from the amount eligible to the contractor at current rates.
- Supplyco reserves the rights to increase or decrease the quantum of work at site without assigning any reason.

- The contractor shall examine the site condition and satisfy himself of the availability of materials, difficulties etc, which may arise during execution before submission of the tender.
- The Contractor's rate must be firm and include the cost of transportation of material to the site, and applicable GST.
- An agreement shall be executed for the work between the contractor and Supplyco in a stamp paper worth Rs.200/- at the expense of the contractor.
- If the contractor fails to complete the work within the stipulated time, a delay penalty to the tune of @ 0.1% per day, will be imposed subject to a maximum of 10%.
