Terms and Conditions

- 1. The bidder is allowed to quote for all the items or part thereof. They are also allowed to make suitable alternative offers.
- 2. Every bidder should furnish an earnest money of 1% of the total cost of the offer or Rs.1500 whichever is higher in favour of the Director, CFRD, Perinjottakkal P.O, Konni.
- 3. The rate will be considered firm for acceptance till the date mentioned above. Offers not stipulating the period of firmness and quotation with price variation clause and /or subject to prior sale condition are liable to be rejected.
- 4. The quotation will be opened on the appointed day and time in the office of the undersigned, in the presence of such of those bidders or their nominees with authorization letter.
- 5. If any bidder withdraws from his offer before the expiry of the period fixed for keeping the rates firm for acceptance, the earned money if any, deposited by him will be forfeited or such action taken against him as the CFRD thinks fit.
- 6. The period for the supply of equipments is 7 days from the date of Supply Order. CFRD reserves the right to relax the period of supply, if it deems necessary.
- 7. The bidder shall clarify or specify whether the articles offered bear Indian Standards Institution Certification Mark. In such cases, they shall produce copies of certification mark along with their offers in support of it.
- 8. The right of final acceptance, rejection of the offers or negotiation with the bidders rest entirely with the CFRD, who do not bind themselves to accept the lowest or any quotation. But the bidder on their part should be prepared to carry out such portion of the suppliers included in their quotation as may be allotted to them.

- 9. In case of material of technical nature, the successful bidder should be prepared to guarantee satisfactory performance for a minimum period of one year.
- 10. Communication of the acceptance of the offer normally constitutes a concluded contract. Nevertheless, the successful bidder shall also execute an agreement for the due fulfillments of the contract with in the period of 5 years from the date of receipt of acceptance.
- 11. The successful bidder shall, before signing the agreement and within the period specified in the letter of acceptance of his quotation, deposit a sum equivalent to 5% of i.e. value of contract as security for the satisfactory fulfillment of contract less the amount of money deposit by him along with his quotation. The amount of security may be deposited as DD drawn in favour of the Director, CFRD, payable at Konni.
- 12. (a) The rate quoted for each item should include supply, installation and commissioning and demonstration and required training whichever applicable at the site of CFRD.
- (b) Full payment will be made only after the supplies are actually verified, installed demonstrated along with the required training and certificate of satisfactory performance by CFRD.
- 13. Any sum of money due and payable to the contractor(including security deposit returnable to him) under this contract shall be appropriated by the CFRD and set of any claim of the CFRD for the payment of a sum of money arising out of or under any other contract made by the contractor with the CFRD. Any sum of money due, and payable to the successful bidder or contractor from the CFRD shall be adjusted against any sum of money due to the CFRD from him under any other contracts.
- 14. The bidder shall undertake to supply materials according to the stipulated specifications.
- 15. No representation for enhancement of rate once accepted will be considered.
- 16. Bidders should be prepared to accept orders subject to the penalty clause for forfeiture of security in the event of default in supplies or failure within the stipulated period.
