The Kerala State Civil Supplies Corporation Ltd. (SUPPLYCO) invite Expression of Interest from business units located in Kerala interested to Supply Kudampuli (Garcinia Cambogia) under Sabari Brand as per Supplyco Requirement under the following Terms and Conditions.

1 Introduction

Supplyco is engaged in market intervention operation to control the prices of essential commodities in the state of Kerala. Apart from this core objective, Supplyco is also marketing branded food products under brand name of Sabari. Considering the demand for Kudampuli(Garcinia Cambogia) in the open market and as part of the programme to increase the portfolio of Sabari brand products, Supplyco is intend to market Kudampuli (Garcinia Cambogia)in Sabari brand in Kerala.

Expression of interest is called from firm having potential to supply as per Supplyco requirement. Firms will be shortlisted based on the technical evaluation and shortlisted the firms will only be considered for participating in the price bid.

2 Scope of work

The scope of work will include processing, packing and distribution of product to Depots/Outlets of Supplyco as per requirement..

3 Validity of Offer

The offer for EOI as per this document shall be valid for a period of three (3) months initially which may be extended further if required by Supplyco.

4. Instructions

The Expression of Interest is to be submitted in the manner prescribed below:-

- a) Hard copy of duly filled, signed **Annexure A** showing the expression of Interest along with the copy of the supporting documents as specified in **Annexure A** is to be submitted in sealed envelopes superscribed, as ***“EOI for processing, Packing and distribution of Kudampuli under Sabari Brand ”***.
- b) Soft copies of the **Annexure A** and supporting documents as specified in **Annexure A**.

All information to be submitted and failure to furnish complete information as mentioned in the EOI (**Annexure A**) or submission of the proposal not substantially responsive to the EOI in every respect will be at the Bidder's risk and may result in rejection of the proposal.

5. Terms and Condition

A) Pre Qualification Criteria

Following will be the minimum pre-qualification criteria. Each applicant should possess all the following pre-qualification criteria. EOI not meeting the minimum pre-qualification criteria is liable to be rejected and will not be evaluated. Applicants meeting the qualification criteria may be invited for presentation / proposal before the selection committee of Supplyco. Detailed tender document will be subsequently issued to the short listed applicants only.

- a. The unit shall have all the required machineries for processing the raw material and packing and distribution of finished goods .with following quality specifications

Kudampuli (pot tamarind, Malabar Tamarind, cambodge) is the dried Pericarp lobe of the fruit of the tree *Garcinia gummi-gutta*(*Garcinia cambogia*), . The ripe fruit rinds are separated and spread in thin layers and sun dried or smoke dried or machine dried under hygeinic conditions .

- It shall possess taste and flavour characteristic of Kudampuli
- It shall be dark brown to black in colour and leathery in texture
- It shall be free from fungal growth and artificial colouring. taste and
- The product shall meet all the mandatory requirements of FSSA 2006
- It shall conform to following standards

- b. The manufacturer will supply the goods on the basis of requirement.
- c. The production process and the quality of the product will be directly monitored by Supplyco.

- d. Supplyco will evaluate the parties upon the interest submitted considering their production capacity, experience, plant & machinery, technology used etc. For evaluating the expression of interest submitted by the parties, the Supplyco will take the help of experts in this field preferably from a Government agency if required.
- e. After the technical evaluation and short listing of the tenderers, the Supplyco will invite quote from the short listed units for finding out the L1 tenderer for executing agreement.
- f. After the technical evaluation and short listing of the tenderers, the Supplyco will invite quote from the short listed units for finding out the L1 tenderer for executing agreement.
- g. Process should follow the Good Manufacturing Practices norms.
- h. All the requirement related to licenses and certificates from Panchayat, Pollution Control Board, Factories and Boilers Dept. etc are available.
- i. The firm should hail from Kerala and should have MSME certificate
- j. The Firm should have capacity of 100 MT.

6. Evaluation Criteria and Method of Evaluation:

- a) Screening of EOIs shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted.
- b) EOI will be evaluated for short listing inter alia based on their past experience of handling similar type of project, financial strength of firm, Quality certifications. Decision of the Selection Committee will be final.
- c. Based on the marks/grade scored in the evaluation, parties will be shortlisted. The marks for evaluation will be as per **Annexure B** .
- d. Firms who qualify as per the eligibility conditions will be required to participate in a limited tender containing all the details, date of which will be published later.
- e. Supplyco will take up references and reserves the right to pay due heed to the bidder's performance elsewhere and any past experience from Supplyco.

7. EOI Response

- 1) Bidders must ensure that in their Bid all the details is submitted as per Annexure A.
- 2) Special comments on the objectives and scope of the service projected in the enquiry may also be submitted along with the offer.
