Terms & Conditions

Maintenance work in Chilly godown, Willington Island

- The work shall be executed as per the specification of drawing, estimate and the direction of the Civil Engineering wing of Supplyco.
- The EMD shall be drawn from Nationalized / Scheduled Bank in the form of crossed DD in favour of Managing Director, Supplyco, payable at Ernakulam.
- EMD of unsuccessful tenders will be refunded without any interest on finalization of the contract with the successful Tenderer or on the expiry of the validity period whichever is earlier.
- The successful tenderer will deposit a Security Deposit of Rs.11,000/- in the form of a crossed DD in favour of Managing Director, Supplyco, payable at Ernakulam.
- The completion time of the project is 60 days from the date of acceptance of the Work order.
- Payment to the contractor shall be released only as per the certification and recommendation of the Civil Engineering wing of Supplyco.
- Extra items, if any, shall be carried out only after getting prior approval from Supplyco.
- SD will be refunded after expiry of the defect liability period and work certification by the Civil Engineering wing of Supplyco as per the PWD norms.
- All statutory deductions shall be made from the amount eligible to the contractor at current rates.
- Supplyco reserves the rights to increase or decrease the quantum of work at site without assigning any reason.
- The contractor shall examine the site condition and satisfy himself of the availability of materials, difficulties etc, which may arise during execution before submission of the tender.
- The Contractor's rate must be firm and include the cost of transportation of material to the site, and applicable GST.
- An agreement shall be executed for the work between the contractor and Supplyco in a stamp paper worth Rs.200/- at the expense of the contractor.
- If the contractor fails to complete the work within the stipulated time, a delay penalty to the tune of @ 0.1% per day, will be imposed subject to a maximum of 10%.
