2. The last date of receipt of tender to the under signed is up to 1.00 pm on or before. 21.05.2025.

4. The Additional General Manager(P&A) KSCSC, Ernakulam may at his discretion to decide on extending the date of auction. Such extension shall be binding on the tenderers.
5. The rate offered for the vehicle should be quoted in Tender Schedule I (applicable Tax extra) which is appended along with the terms and conditions.
6. Each tender should be accompanied by an EMD for Rs. 10,000/- (Rupees ten thousand only) in the form of Demand Draft drawn in favour of The Kerala State Civil Supplies Corporation Ltd , payable at Ernakulam . Tenders not

accompanied by EMD shall not be considered. The EMD will be returned to all unsuccessful tenderers/auctioners as soon as the decision in the tender/auction is finalised.

7. a) The properly signed tender form & DD of Rs.10000/- should be kept in a sealed cover and “ **Tender form &DD of Rs.10000/-** “ should be written on top of that cover.

b) Schedule I should be kept in another sealed cover should be written as “**Schedule I** “ on the top of that cover.

c) Both cover should be enclosed in a sealed big cover should be written as “**Quotation bid for vehicles** “ on top and also should write **Name &Address of tenderer or auctioner** preferably in the left side of the cover .

8. The bid will be opened only after the auction is over.

9. The rate which quoted in the tender or in the auction whichever is higher will be accepted. All the other tenders will be rejected.

10. The successful tenderer/auctioneer should remit the balance amount within three days after the receipt of sale confirmation letter through Bank account of KSCSC, Ernakulam. Otherwise the tender will be cancelled and EMD will be forfeited.

11. The Additional General Manager(P&A), KSCSC, Ernakulam is competent to take necessary action to dispose the vehicles and recover the balance amount from the successful tenderer by way of risk and cost, if the successful tenderer fails to remit the amount and take delivery of vehicle within the period mentioned in the tender form.

12. The decision of Additional General Manager(P&A) , KSCSC, Ernakulam will be final subject to the approval of The Managing Director, KSCSC, Ernakulam.
