### **Terms and Conditions for CMR Vehicle Contract**

1. Movement of the vehicle will be reckoned from Taluk Depot, Kerala State Civil Supplies Corporation Perumbavoor and reporting time of vehicle will be as instructed by the concerned officer.
2. The hiring will be for a period of one year from the date of commencement of the agreement. Sundays will be normally holiday. In urgent cases, the vehicle will be made available even on Sundays according to the instruction from the officer in charge.
3. The rate quoted by the contractor includes the cost of fuel, lubricating oil, salary of driver, parking fees, maintenance cost etc. and Supplyco is not liable to make any payment on this account.
4. The contractor should agree to meet all the expenses on account of accidents, causing loss of life/property and payment on account of violation of traffic rules, if any, and Supplyco is not liable to meet any kind of such expenses.
5. The vehicle supplied should be neat, clean and duly insured and drivers should have proper valid license. The vehicle supplied should not be more than five years old.
6. Drivers should not attend duties in intoxicated condition, consume alcohol/narcotic/any other prohibited drugs while on duty and should be polite in behavior.
7. If there is any failure to arrange vehicle on any day in a month as per the agreement, an amount equal to one day on proportional rate will be deducted from the monthly rent.
8. The lump sum quoted rate will be applicable for the first 1750 KM per month for 25 working days. Extra kilometers run over and above per month will be paid per kilometer.
9. Payment of hire charges will be made on a monthly basis. Submission of the bill along with the completed Log book is the responsibility of the contractor on completion of each month, duly certified by the concerned officer of CMR inspection in charge of the vehicle.
10. Payment against the bill will be disbursed only after verification with the Duty register of Paddy division.
11. Supplyco reserves full right to discontinue the service of hired vehicle at any time without any prior notice.
12. Supplyco reserves the right to extend the contract for a further period of 1 month at the same terms and conditions.
